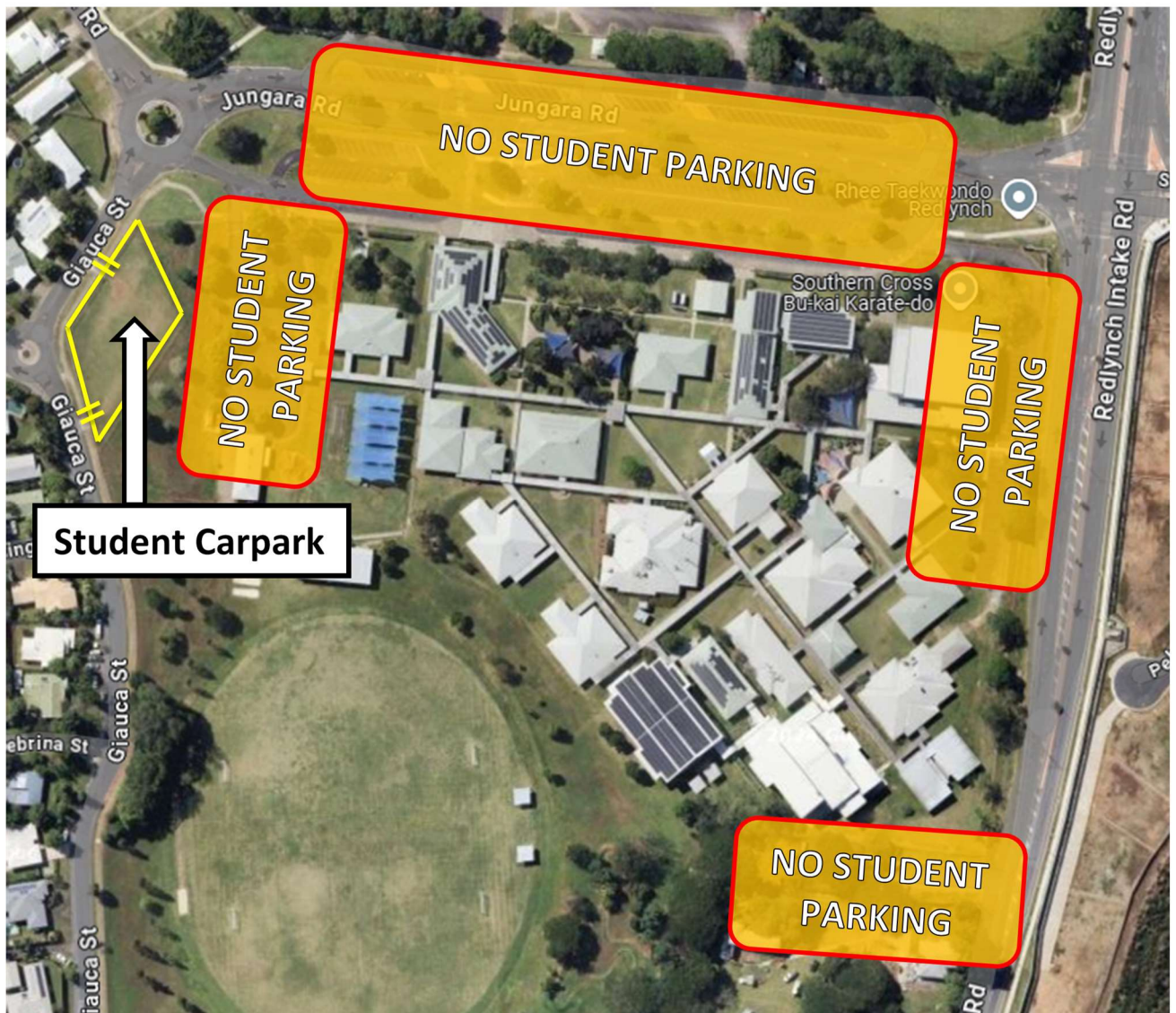

Student Parking

Following approaches to the Cairns City Council, it has been agreed that in the interests of the safety of students, and in the interests of the rights of neighbours, students are to park in the following streets adjacent to the school grounds:

- **Off Giauca St** – block of land at the top of the college grounds, as outlined in the map below, unless authorised by Principal/DP to park elsewhere.



- Students are **NOT permitted to park:**
 - In the carparks in **front of the school** (both Primary and Secondary)
 - In either of the **staff carparks**
 - In **Mayo Circuit** (the new housing development behind LC7)
